ACH Credit Processing

ACH credit is an easy and convenient way to pay. Vermont Department of Motor Vehicles needs specific information from you to correctly apply your payment to your account. This is especially important if you have more than one account with the DMV.

The first step is to set up an account with your financial institution. You will need to know what information is needed and the correct format to use. Using the wrong information and format will delay your payment. Please follow the instructions carefully. Payments which do not process correctly may be subject to late-filing penalties and interest.

When setting up your account, you will need to provide the following information (see detailed instructions on the following pages) to your financial institution or payroll company:

Bring this guide with you when you set up your ACH credit account with your financial institution or payroll company.

The segment identifier is **TXP**. This directs your payment to the Vermont Department of Motor Vehicles.

Taxpayer ID

New Vermont DMV Account assigned by the Vermont Department of Motor Vehicles: 3-letter Taxpayer ID Prefix (chart on page 2) plus 13 digits. Example for Fuel Tax: FUL + 1234567890123 = FUL1234567890123

Tax Type Code

Select from one of the codes listed in the chart on Page 2. The code must be exactly 5 digits.

Example: Fuel Tax – 05000

Tax Period End Date

Enter the date as year, month, day – YYMMDD. Do **not** use the tax due date.

Example: December 31, 2019 = 191231

Tax Amount Type

Select and use the option that applies to your payment:

- Use Letter “T” if you are paying the payment shown on your tax return or an estimated tax payment
- Use Letter “B” if you are paying the balance due on your Statement of Account or payment for the amount due on an audit

Routing Number

Use the routing number for People’s United Bank: **021052053**

TERM	TERM OPTIONS	MEANING
Field Name		
	Segment Identifier	TXP must be entered in this field. This identifies the transaction is related to tax liability.
	Separator	An asterisk (*) must be entered to separate data elements in the CCD+ record.
	Taxpayer ID	Your 13-digit account number issued by the Department [XXX #####] This number always begins with 3-letter OR If using the legacy ids do not include the 3-letter prefix 1) Your 4-digit account number issued by VT DMV [###X] 2) Your 8-digit Personal Identification number [#####X]
	Tax Type Code	Refer to chart on page 1 for the correct 5-digit code
	Tax Period End Date	The date is entered as YYMMDD. YY = year; MM = month; DD = day. Enter the tax period end date. When paying a Statement of Account, enter the date of the statement.
	Tax Amount Type	The Tax Amount Type value is "T" or "B" depending on the type of payment being made.
	Tax Amount	Enter the dollar amount being paid. The amount field must always contain cents.
Field Requirement		
	Mandatory (M)	The field or data element shall appear in the convention.
	Optional (O)	The use of the field or data element is optional.
Data Element Type		
	AN	The string type data element is symbolized by the representation AN. Contents of string type data elements are a sequence of letters, digits, spaces, and/or special characters. The contents shall be left-justified. Trailing spaces should be suppressed unless they are necessary to satisfy a minimum length requirement.
	ID	The identified type data element is symbolized by the representation ID. An identifier data element shall always contain a value from a predefined list of values.
	DT	The date type element is symbolized by the representation DT. Format for the date type is YYMMDD. YY is the last two digits of the year (00-99 with 00 = 2000), MM is the numeric value of the month (01-12) and DD is the numeric value of the day (01- 31).
	N2	The numeric type of field or data element is represented by the two-position representation N2. N indicates the numeric and 2 indicates the decimal places to the right of a fixed, implied decimal point. The decimal point is not transmitted. It is intended that this number will always be positive for the TXP application. In the TXP convention, the amount fields are defined as N2 type data elements. Thus, \$1,200.00 would look as follows *0000120000*. Note for zero-dollar amounts: this data element type may contain one character - 0.

COMMON PROBLEMS WITH ACH CREDIT PAYMENT SUBMISSIONS

- **Invalid Tax Type Code:** The code is too short or does not match a code listed on Page 2.
- **Filing Period formatted incorrectly:** The format is YYMMDD. Note – Do not use the tax due date.
- **Taxpayer ID formatted incorrectly:** Do not include dashes in the account number.
